

Data Privacy Policy

This Privacy Policy applies to the Are you tired Tool (“the Tool”). Please read this Privacy Policy carefully and feel free to contact us if you have any questions.

This Privacy Policy explains what personal information may be collected and processed about you when you complete the survey in order to calculate your fatigue score and how we may use that information. It includes a description of your data privacy rights.

The use of the Tool is optional, and if you do not want your personal information to be processed by Sobi Czech Republic as described below, please do not complete the survey.

Data controller

Personal data

Personal data means any information relating to an identified or identifiable natural person.

Through the use of the Tool by the user, Sobi Czech Republic does not process personal data that may directly or indirectly lead to the identification of a natural person.

Your answers to the following questions are used solely for the purpose of calculating your fatigue score. Your answers are not collected or stored by Sobi Czech Republic and therefore cannot be linked to you after you close the Tool.
